

# PRIVACY POLICY

This Privacy Policy aims to inform all persons who browse the website [www.paugasolacademy.com](http://www.paugasolacademy.com) (the "Website") about the processing of personal data carried out through it. This Privacy Policy may be modified, and once published, such modifications will apply to you.

Your personal data will be processed in an effective, proportionate and responsible manner, in strict compliance with the provisions of Regulation (EU) 679/2016 General Data Protection Regulation (GDPR), Organic Law 3/2018 on the Protection of Personal Data and Guarantee of Digital Rights (LOPDGDD) and any other regulations that may be applicable.

## 1. Data Controller

## 2. Purposes and legal bases of processing

PGE processes the personal data provided by data subjects for the following purposes and under the following legal bases:

Management of registration and the relationship with participants and potential participants in the PAU GASOL ACADEMY and any other event organized by PGE, as well as the management of inquiries and other requests that data subjects send to PGE.	The existence of a contractual or pre-contractual relationship. The legitimate interest of PGE in resolving inquiries and requests raised by data subjects.
Management of catering and dining services, as well as ensuring the safety of participants.	Protection of vital interests of the data subject (art. 9.2.c GDPR) within the framework of the existing contractual relationship.
Taking and subsequent dissemination of photographs and videos of participants on social media profiles, Website and promotional materials of PGE.	Express consent. Consent may be withdrawn at any time.

Sending personalized commercial communications about sporting events organized by PGE, by electronic and/or conventional means, as well as regarding future editions of the PAU GASOL ACADEMY.	Express consent and/or the legitimate interest of PGE.
Sending personalized commercial communications from third-party sponsors and collaborators with the PAU GASOL ACADEMY, about products and services related to the world of sports (if expressly consented to).	Express consent. Consent may be withdrawn at any time.
Management of sending surveys and/or evaluations relating to the quality of services provided by PGE.	The existence of a contractual relationship and/or the legitimate interest of PGE.
Registration and participation in sweepstakes and promotional activities organized by PGE.	The existence of a contractual relationship through acceptance of the corresponding legal terms of the sweepstakes and/or promotional activity.

### 3. What categories of data do we process?

In accordance with the aforementioned purposes, we will mainly collect the following personal data:

- Identification data: name, surname, date of birth, ID and image.
- Contact data: email address, postal address and mobile telephone.
- Health data: food intolerances and/or allergies and regular medications.

### 4. Recipients and international data transfers

The personal data provided may be communicated to other companies in the PGE group for internal administrative purposes. Likewise, with your prior consent, we may communicate identification and contact data of participants, as well as of parents or guardians, to Orientis Business Services, S.L. so that they can provide you with information related to the promotion of events and other campaigns in Spain that are not organized by PGE (in such case, you can consult additional information on how your data will be processed at [www.akawsports.com](http://www.akawsports.com) or by contacting [info@akawsports.com](mailto:info@akawsports.com)).

On the other hand, PGE has service providers and other collaborators who act as data processors and help us carry out our work.

PGE, in compliance with data protection regulations, has signed contracts with all its processors that regulate the processing of personal data. If you wish to obtain more information about the data processors, you can contact PGE through the channels established in this Privacy Policy.

Except in certain situations, PGE will not transfer data to service providers located outside the European Economic Area (EEA). In the event of having to make a data transfer outside the EEA, PGE

will ensure that the service provider in question offers an adequate level of security in terms of data protection in accordance with applicable regulations.

Finally, it is possible that, on certain occasions, we must communicate your data to third-party recipients, including Courts and Tribunals, State Security Forces and Bodies or the Public Prosecutor's Office, as well as consulting and legal advisory firms.

## **5. Retention periods**

PGE will retain your personal data while a contractual relationship exists or until you exercise your right to erasure, cancellation and/or limitation of the processing of your data and, in any case, for the time necessary to fulfill the purpose for which they were collected.

Once the purposes have been fulfilled, PGE will retain the personal data duly blocked to the extent that liabilities may arise for PGE or when required by applicable regulations.

## **6. Rights of data subjects**
